Entry Fees:

WC = \$50.00 (no limit) - Late or Walk up entry additional \$10.00 per entry

Senior Singles = \$20 (limit 10 dogs)

Conformation Certificate -\$15.00—Register day of event or complete entry form

Refund Policy: Entry fees will be refunded, if requested in writing prior to the closing date. After the closing date, refunds (Entry fee less \$15.00 club fee) will be made for: Illness of a dog, injured dogs or death of the dog with a veterinarian's certificate. Notify the Test Secretary and send documents to the address listed.

NOTE: Bitches in season will be allowed to run at the end of the running order. Please inform the stake marshal if your bitch is in season.

WC Performance Requirements: LRC rules apply—everything else PRLRC rules apply.

Running Order: We do our best to post the running order on www.prlrc.org or will be emailed prior to the test.

Rules:

Senior Singles: Ages 8 yrs and up. One single land and water retrieve of either a bird, bumper or dokken. Prizes awarded categories TBA. Limited to 10 dogs. Seniors will run immediately following the WC dogs for both land and water.

PRLRC Test for all retrievers: Pass/Fail - Dogs must be minimum of 6 months old

WC Test: The dog will retrieve one single dead bird at approximately 50 yards on land in light cover. The dog must not be gun shy. The dog will retrieve two dead ducks from water as back-to-back singles to show willingness to reenter the water. The dog need not be steady, so a dog may be held on the line by the collar. Delivery to hand is not required, but it is suggested that the area of delivery be within easy reach of the handler. This area will be determined by the judge prior to the beginning of the test. Dogs must be at least six months of age. Immediate failure if bird boy has to help or assist dog. Popper guns, wingers and duck calls will be used. It is acceptable to encourage the dog to return via voice.

Conformation Certificate

offered by the LRC, Inc. is a non-competitive conformation evaluation program open to all Labrador Retrievers, over one year of age, including spayed and neutered dogs. Labradors will be judged in accordance with the Standard. The Evaluation Sheet contains (8) conformation and temperament categories for a judge to consider on a numerical basis. Each dog will be scored in each category using the number (1) through (3) point system described. <https://thelabradorclub.com/events-programs/lrc-certificates-awards/conformation-certificates/>
